No. SEC. 63/2022/125 : In exercise of powers conferred under Article 243K of the Constitution of India and Section 114 (1) of the Assam Panchayat Act, 1994 (as amended up-to-date) and Rule 15 and Rule 16 of the Assam Panchayat (Constitution) Rules, 1995 (as amended up-to-date) the Assam State Election Commission, on this **2nd day of April, 2025** hereby notifies the schedule of General Election to the Panchayats in the State of Assam.

The General Election to the Panchayats in Assam will be held in 2(two) phases as per the schedule enclosed as **Annexure- 1** and the names of districts indicating the phase in which the Panchayat Election will be held therein have been notified as per **Annexure- 2(A)** and **2(B)**.

The respective District Commissioners shall publish Notice of Election under Rule 16 (1) of the Assam Panchayat (Constitution) Rules, 1995 (as amended) on date(s) as per the Election Schedule enclosed herewith at the office of Block Development Officer(s) concerned and at such other places as may be considered necessary by the District Commissioner.

With this notification, the Model Code of Conduct has come into force with immediate effect in the areas where Panchayat Elections are notified to be held.




