PRESS RELEASE

The Draft Photo Electoral Rolls for the 35 Dihing Sessa Constituency under Mising Autonomous Council in respect of Dibrugarh and Charaideu District have been published today, pursuant to the delimitation notification No.ECF293103/1076 dated 10.01.2025, No. E 293103/1215 dated 21.07.2026, No.E 293103/1219 dated 21.07.2026 and other subsequent Notifications issued by the Department of Tribal Affairs (Plain), Government of Assam. The elector's break-up, as per the Draft Electoral Rolls for 35 Dihing Sessa Constituency under Dibrugarh and Charaideu District for the Mising Autonomous Council is provided below:

The electors can check their names on the Draft Electoral Roll either through their EPIC number already allotted by the Election Commission of India, or by downloading the Draft Roll of their Polling Station from the citizen corner on the said website.

Claims & Objections to the entries in the Draft Electoral Roll, if any, can be filed till 03.09.2026. The process to file Claims & Objections can be known by contacting the concerned Electoral Registration Officer (ERO)/Assistant Electoral Registration Officer (AERO)/District Administration. The format of filing Claims & Objections is available in the office of the ERO/AERO as well as on the website of the District Administration and the State Election Commission.

Further, to facilitate wider participation in the forthcoming Mising Autonomous Council (MAC) Election, 2026, the Assam State Election Commission has decided, in line with the initiative of the Election Commission of India (ECI), to consider claims for enrolment from persons who became eligible after 01.01.2026, with reference to 01.04.2026 or 01.07.2026, provided their names are included in the ECI's Supplementary Electoral Roll and they possess a valid Elector Photo Identity Card (EPIC).
